For outdoor shows, shelter from the sun, cold, wind, and rain is required. Under no circumstances will any of our animals be exposed to direct sun, extreme heat and cold or precipitation. We will not do shows outside if the temperature (including wind chill) is below 60°F. If the temperature exceeds 80°F our chinchillas will not be able to attend the show. We request, if possible, that the show be moved to an air-conditioned venue when outdoor temps exceed 80°F.

7. Cancellations and Delays

ATO may cancel shows due to inclement weather and dangerous travel conditions. If this should occur ATO will refund you in full. If you need to cancel, a 72-hour cancellation period is required. *Your deposit will not be refunded*.

From time to time, our arrival time is taken out of our control due to accidents, weather conditions, etc., causing us to be late. If our arrival is delayed, we will call you ahead of time to let you know. We may not always be able to give you an accurate estimate of our arrival due to the unpredictability of weather and traffic conditions. In such circumstances, we will still give you the time you've paid for when we arrive.

If you or your guests are late to the show, and you want us to wait for their arrival, we *can* wait. However, the clock for the show will begin counting down form the 1 hour allotted, beginning at the scheduled start time. Whatever time remains when you are ready to start will be the only time you have for the show.
